CONSIDERING THE ADOPTION OF THE 2017 TOWN OF GATES BUDGET

Supervisor Assini called the Public Hearing to order at 7:00 P.M. The Town Attorney verified that the legal notice had been published as required by law.

Supervisor Assini stated that the tax rate is down 2 cents per thousand in this budget. The levy is up 1% and the assessed value is up 1.3%. The town tax rate is the lowest it has been in many years. The average town tax bill is \$625.72.

Mr. James Gray, President of the Gates Volunteer Ambulance addressed the Town Board regarding a possible co-pay for residents of \$75.00 per service call. They have been absorbing the insurance co-pay; however, it is getting harder to do it. At this time Gates residents do not pay for ambulance service.

Supervisor Assini stated that this matter needs to be addressed. He will contact Mr. Gray to schedule a meeting in the near future.

AUDIENCE PARTICIPATION

He presented the Town Board with a copy of the State's Public Health law which addresses cats. He asked that the Supervisor look into the possibility of creating a town code for cats.

Supervisor Assini stated that he will look into the matter with the Animal Control Officer and the Town Attorney.

Ms. Carol Wolf of Lyell Road asked if Mr. Orsi had contacted the Supervisor. He was to be at this meeting to explain his financial reports.

Supervisor Assini stated that he has not heard from Mr. Orsi. He will be sending Mr. Orsi a letter requesting this information.

CLARIFYING THE APPOINTMENT OF PAUL ARNDT AS THE TOWN OF GATES ASSESSOR
