The Gates Town Board held two Public Hearings and its regular Town Board meeting on Wednesday, November 6, 2019 at the Gates Town Hall, 1605 Buffalo Road, and first one to begin at 7:00 PM. Those present for the Public Hearing and regular Town Board meeting were as follows:

TO CONSIDER A CONDITIONAL USE PERMIT FOR ED JARVIS AT LUTHERAN CHURCH OF OUR SAVIOR 2415 CHILI AVENUE, ROCHESTER, NY 14624 TO OPERATE AN ELECTRONIC CARILLON DEVICE (BELL TOWER) PLAYED PUBLICALLY WITHIN A RESIDENTAL DISTRICT

Supervisor Giunta identified that the Public Hearing scheduled for 7:00PM was erroneously published with incorrect time of 7:15PM and stated that we would wait till that time to conduct it immediately followed by the second one.

Supervisor Giunta called the Public Hearing to order at 7:15PM. He asked if public meeting notice was published as required by law. The Town Attorney verified that the Legal Notice was published as required by law.

Ed Jarvis, Church Council who resides at 99 Riviera Dr., and Pastor Wilkin who resides at 13 Cornflower Dr., N. Chili, addressed the board. The Church is requesting to use a speaker system with four speakers attached to the roof to play hymns in a bell tone. The system is computerized with approximately 2,000 hymns that will play. They are requesting to play them Monday through Saturday at 12:00 PM and 6:00 PM, as well as Sunday before mass at 9:00 AM and 11:15 AM and on special occasions such as Easter, Christmas, Weddings and/or Funerals but no service later than 6:00 PM.

Supervisor Giunta asked how long the hymn would play each time and was informed no more than 5 minutes.

Councilman Tucciarello was concerned some neighbors might find the noise level disturbing, but was informed that if the music is too loud they can turn off one or more of the speakers.

Don Ioannone who resides at 4099 Lyell Rd, goes to mass at Holy Ghost by his home. They also play hymns in a bell tone and has never heard any complaints. He stated that the hymns are played every hour between 8 am and 8 pm for years.

Jim Gray who resides at 1530 Buffalo Rd. stated that the Church is right by the Fire Department and there has not been any resident complaints regarding the trucks with lights going at all hours of the day.

John Zeppetella who resides at 1676 / 1700 Buffalo Rd. stated that as long as it doesn't interfere with the Ambulance or Fire Department it would be nice. Also have bells like this at St. Judes

No further discussion – Supervisor Giunta closed the Public Hearing.

7:30 PM PUBLIC HEARING

APPROVING THE PRELIMINARY 2020 TOWN OF GATES BUDGET

Supervisor Giunta called the Public Hearing to order at 7:30PM. The Town Attorney verified that the Legal Notices for the workshop meeting and Public Hearing were advertised and published as required by law.

Supervisor Giunta stated that on October 24, 2019 the Gates Town Board spent 3 ½ hours reviewing the budget page by page during the budget workshop and decided on a 1% increase of taxes.

The budget for 2019 was \$6.045 per thousand; the proposed budget for 2020 will increase to \$6.11 per thousand. Same rate as back in 2016. In 2019, \$802,000 was to be allocated from reserve funding, however it is realistic looking like \$1.2 million from reserve funds will be used this year. For the 2020 budget we are looking to allocate \$1.34 million from reserve funding. This will leave under \$600,000 in reserve funding which isn't much at all. This will be the first increase in 12 years and the increase will hopefully help build the reserve fund back up. Mary Yates, residing at 538 Valley Creed Rd. wanted verification that for the 2019 budget tax collection was \$10,045,118 million and is being increased to \$10,149,265 million.

John Zeppetella who resides at 1676/1700 Buffalo Rd. stated that the medium home value has dropped from \$104,300 to \$102,700 in the Town of Gates.

Jim Gray who resides at 1530 Buffalo Rd. stated that the Fire Department budget of \$11 million is higher than the entire Town of Gates budget of \$10.1 million. He stated the Fire Department should compensate the Town for collecting their taxes.

Supervisor Giunta stated that with a \$.07 increase per thousand, a \$100,000 home will actually only see an increase of \$7.00 and if \$200,000 a \$14.00 increase. Also mentioned that for the past 12 years because of the surplus in reserve funding we were able to share in the benefit with the residents in utilizing it to subsidize tax increases now we have depleted and have to increase the rate.

Councilman Tucciarello stated that because of the decrease in assessments of \$3.02 town residents will actually see a decrease in their taxes.

No further discussion – Supervisor Giunta closed the Public Hearing.

AUDIENCE PARTICIPATION

Don Ioannone who resides 4099 Lyell Rd. first wanted to congratulate Supervisor Giunta, Councilman Tucciarello and Councilman DiPonzio for winning their elections. He then asked about the storm sewer by on the corner of Baier Dr. and Spencerport Rd. which seems to be approximately 4 inches higher than the road. He was informed that the state needs to fix it before the road can be paved.

Don Romanchych who resides at 149 Matilda Dr. is concerned about an 80 - 90 foot dead tree at 139 Matilda Dr. which is the property of the Town of Gates. It's been going on for years. He is concerned it will fall down on the power lines and/or someone's home. He stated a couple of years ago during a storm a couple of large limbs fell onto power lines and knocked out power for a couple of days. Highway Superintendent Kurt Rappazzo stated that the tree is on their list to be removed. Daniels Tree Service does not have the equipment to take care of it, so he will be looking for a different company.

Councilman Cordero suggested maybe having RG&E / Birchcrest look at it because of the power lines.

Mr. Romanchych also congratulated Supervisor and councilman on the election win
